

# Note From **Board Chairman and President & CEO**

Dear Colleagues,

As you'll find in the following annual report, there has never been a better time to be in Illinois. Our state has generated great momentum as a global business destination. Our data analysis shows that 440 projects expanded or located in Illinois in FY24 (up 15.2% over last year), generating \$12.5B in investment (up 85.6% over last year) and 12.9K jobs (up 37.9% over last year). More and more companies are making pro-Illinois decisions — but this is just the beginning.

This momentum starts with Team Illinois, a coalition that includes Governor Pritzker, the Governor's Office, Intersect Illinois, DCEO, and our network of partners throughout the state that work together to pursue economic development and growth. This partnership makes for more efficient, intentional, and effective efforts in attracting new opportunities. Economic development remains a focal point for the State, which has introduced new programs to attract companies in high-growth industries such as quantum, semiconductors, EVs (electric vehicles), and clean energy.

With Illinois now on strong financial footing, the State is putting even more emphasis on business attraction by investing in site readiness and development initiatives such as our own Vetted Sites program. We're also working closer and smarter than ever before with site selection professionals throughout the country so they are clear on the assets — including our skilled workforce, unmatched infrastructure, and top-tier education system — that make Illinois so attractive.

Our successes are evident in the examples of Intersect Illinois-assisted projects from FY24, which account for 2,738 new jobs (up 158% over last year) and \$2.05B in investment (up 47% over last year), included in this report.

Telling the “Why Illinois” story and raising Intersect's profile as a key driver of economic progress have also been priorities for us. Our organic social media audience is up 1,442.5% over the previous year and our leads generated from our enhanced digital marketing efforts were up more than 411%.

Finally, over the last year we initiated a strategic effort to grow our reach and impact as an organization by transforming our board to exclusively comprise CEO, president, managing and executive director, and market leader-level members. During this time we added more than 30 new board members while establishing committees where they can more deeply lend their expertise and experience in support of our mission to bring jobs and economic prosperity to Illinois. We are grateful for the leadership of Paulina San Millan, who served as our interim CEO, amidst this period of positive growth and transition.

Driving economic growth to communities across our state impacts us all, and we are grateful to our Team Illinois partners who are leading this work alongside us as we make the case to businesses across the nation and the globe to **#BeinIllinois**.

## Project **Highlights**

### Aluflexpack



Aluflexpack AG, a leading Swiss manufacturer of premium circular flexible packaging and barrier solutions, announced it is expanding its operations to Bolingbrook. Production is expected to begin in December 2024, and the facility will be key to servicing the growth of existing U.S. customers.

“We are convinced that this strategic move will not only fortify our presence in a key global market, but also position us for sustained growth in the future,” said Johannes Steurer, CEO of Aluflexpack AG.

### Aqua Cultured Foods



The food tech startup pioneering alternative seafood announced it will expand in Chicago’s West Loop for faster job creation. The company received EDGE for startups to assist in establishing its production facility that will stimulate economic growth and bring jobs.

“The resources provided by EDGE will immediately help us have a positive economic impact on the state, and ultimately help build the local food tech industry, an important industry for Illinois’ future,” said Brittany Chibe, CGO at Aqua Cultured Foods.

### Bedrock Materials



The pioneering battery technology startup chose to locate its research & development (R&D) headquarters in Chicago. The company, which originated out of Stanford University, plans to expand its R&D and manufacturing footprint in Illinois after it recently closed \$9M in seed funding.

“The choice to come to Chicago was an easy one. There is arguably one active laboratory in America that has produced a successful automotive battery chemistry, and it’s here,” said Spencer Gore, CEO of Bedrock Materials.

### Gotion



After a nationwide search, Gotion decided to locate its new state-of-the-art \$2B EV lithium battery manufacturing plant in Manteno, speaking to the state’s growing reputation as an EV manufacturing powerhouse. The plant is expected to begin production in 2024 and to create more than 2.6K good-paying jobs. The State will also fund a manufacturing training academy nearby to train and prepare regional employees for the new jobs.

“All that we see here [in Illinois] are of enormous value to us: an enabling business environment, a supportive state government for the new energy industry and their highly efficient work, as well as the prospects of the State of Illinois in the coming years,” said Li Zhen, chairman of Gotion High-Tech.



### Mazen Animal Health

Mazen, a pioneer animal health company developing novel maize-based vaccines, opened a manufacturing facility in Mason City. The company purchased the former Bayer/Monsanto seed facility and is investing in the region with plans to employ 24 people.



### Wittenstein

The German family-owned firm Wittenstein expanded its operations manufacturing gearboxes and mechatronic drive components at its American headquarters in Bartlett. The growing company added more than 32K square feet of production and office space, noting the state's central location and infrastructure as a key reason for its decision to expand in Illinois.

"Bartlett's central location in the industrially strong American Midwest means it fulfilled all of the essential conditions for our decision, such as proximity to customers, skilled specialists, and dependable suppliers," said Peter Riehle, president & CEO Wittenstein North America.




### Ymer

Ymer Technology, the Swedish manufacturer of EV components for the heavy equipment industry, located its new U.S. headquarters in Buffalo Grove. The company invested \$5.7M to produce cooling technology and thermal management systems for EVs and will create more than 30 jobs.

"We completed an exhaustive nationwide search for a new U.S. location. The Department of Commerce and Economic Opportunity, Lake County Partners, and the Village of Buffalo Grove worked together to support our site selection and assembled an attractive offer that highlights Illinois' talent, work ethic, favorable climate, and vast network of EV leaders," said Frederik Peterson, the founder of Ymer Technology.

# Supporting Growth

## Project Submissions

There was a 43% increase in project opportunities distributed through Intersect Illinois' RFI submission system that were interested in a downstate location in FY24.

**51 unique communities were added** to the real estate database and proposal management system.

## Vetted Sites

Top sites based on characteristics including acreage, utilities, logistics, permitting and entitlement, workforce, ownership, local and state incentives, and environmental and topographic conditions.

In FY24 **40 sites were vetted** for the program, providing infrastructure data for fast-moving projects, while also helping properties and communities understand opportunities for improvement that would prepare them for additional growth.

## Quantum Development



Building on a record of historic investment by the State, Intersect Illinois has helped lay the groundwork for Illinois to become a global hub for quantum computing. The state's world-class talent, infrastructure, and existing ecosystem of major research institutions, universities, and national laboratories have positioned Illinois to become a leader in quantum technology, which has the potential to tackle many of the biggest challenges in health care, agriculture, national security, and more. The work done in FY24 led to the following:

Intersect Illinois hired its inaugural Chief Quantum Officer, Preeti Chalsani, who works closely with leaders within Illinois' science, technology, innovation, government, and economic development communities to lead business development efforts related to quantum.

The announcement of the Illinois Quantum and Microelectronics Park (IQMP), a first-of-its-kind park for quantum scale-up and related quantum and microelectronics research and development, is supported by a \$500M investment from the State. Anchor tenant PsiQuantum will build the first utility-scale, fault tolerant quantum computer, and DARPA will house its Quantum Proving Ground applied research program to prototype and test promising quantum technologies.

## SelectUSA 2024

Intersect Illinois collaborated on hosting multiple events including Team Illinois' presence at the SelectUSA Investment Summit, the country's highest-profile foreign direct investment (FDI) event. **Telling the *Why Illinois* Story on the Global Stage**

In ongoing efforts to foster collaboration and attract investment to Illinois, Intersect Illinois took part in trade delegations to the UK, Canada, and China. Intersect Illinois regularly engages in visits that provide unique opportunities to connect with business and government leaders in key markets, build strong relationships, promote Illinois’ position as a global business destination, and ultimately draw international companies to the state.



**UK** – Intersect Illinois took part in a trade mission to the United Kingdom to strengthen ties between UK leaders and over 40 Illinois business and government leaders who participated in the mission.



**Canada** – During the Canada trade mission, the delegation, including Governor Pritzker, participated in the 2024 U.S.-Canada Summit and met with key government leaders and business leaders in quantum, finance, EVs, technology, and other growing sectors.



**China** – Members of Team Illinois including Intersect Illinois Chairman John Atkinson traveled across China as part of a broader Midwest trade delegation that engaged with over 50 Chinese companies and discussed expansion opportunities with business leaders throughout the country.

Continued focus on lead generation, up 38% YoY with continued improvements in targeting and analysis, including machine learning




### Community Research Support & RFI Training:

## FY24 Company Relocations & Expansions Generated:






**Square Footage by Industry**




**Projects by Industry**



